## MVF awards four scholarships to Village high school graduates

The Montgomery Village Foundation (MVF) once again joined the Watkins Mill High School Parent Teacher Association (WMHS-PTSA) and Gaithersburg High School (GHS) to continue the MVF Scholarship Fund, now completing its 25<sup>th</sup> year. Since the program's inception in 1991, scholarships amounting to almost \$50,000 have been awarded to Village high school seniors. Through this fund, Village residents are able to show their support by encouraging student leadership and scholastic achievement while assisting graduating seniors in furthering their education. The amount available for each school is entirely determined by the amount donated by Village residents.

This year, MVF scholarships were granted to four Village students: Kani Manogaran and Jennifer Milhiser of Watkins

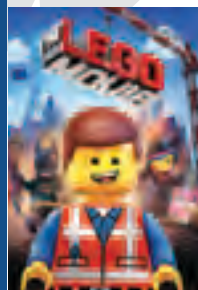

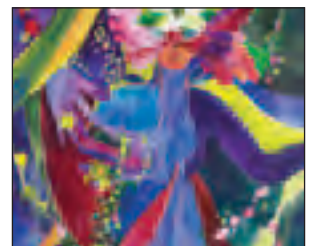

### EVP'S MESSAGE

**Common Ownership Communities (COC) Fee will increase** from \$3 per household per year to \$5 per year, effective Friday, July 1, 2016. On May 26, the County Executive forwarded proposed regulation 3-16, and the Planning Housing and Economic Development (PHED) Committee recommended its approval after a work session on June 20. MVF opposed the fee increase, questioning its need, and noted that the fee increase was in conflict with common ownership communities' (COC) budgets.

The PHED Committee asked the Director of Housing and Community Affairs (DHCA) to alleviate the impact of the fee increase on COCs, and the director noted that his department will provide COCs with the option of paying the fee for the FY 2017 budget in two installments. The first installment of \$3 will be due in July 2016. The second installment of \$2 will be due no later than the end of January 2017. This will be a one-time opportunity.

Looking ahead to FY18, DHCA will provide COCs with a single \$5 per unit charge. The new funds will be used to enhance staffing to administer the CCOC program; adding a fulltime investigator and an Office Services Coordinator; providing better technology resources to develop a case management system for all CCOC complaints; upgrade the existing COC registration database and provide resources for improved community out-

reach; and training. DHCA will begin managing the CCOC programs and department on Friday, July 1, after many years of being under the auspices of the Department of Consumer Affairs.

**Montgomery Village Shopping Center Meeting** - Atlantic Realty Companies (ARC) sponsored a community meeting on June 2 at North Creek Community Center. This meeting was required by the Planning Board prior to a sketch plan or site plan being formally submitted. The sketch plan is expected to be submitted to the Planning Department before the end of June for review.

The president of ARC gave a presentation very similar to the community meeting held on April 21 and responded to a variety of questions including housing density, vehicular access and circulation, play areas for children living in the proposed residential units and apartment building height, among others. Generally, residents in attendance appeared to be enthusiastic about the plan.

There will be many other opportunities for resident comment before the Planning Board in the coming months. The Commercial Architectural Review Committee (CARC) will review the concept plan at 9:15 a.m. on Friday, June 24, in the North Creek Board Room, 20125 Arrowhead Road.

**The comprehensive zoning of all properties in Montgomery Village** continues to be processed by the county council. The Planning Board has recommended all the zoning recommendations in the recently adopted Montgomery Village Master Plan and the overlay zone. MVF Board President Pete Young presented testimony on behalf of the Board at a public hearing during the county council's meeting on June 14, endorsing the zoning proposed in the master plan, including the overlay zone. **The National Transportation Safety Board (NTSB)** issued its Final Findings on the 2014 December Jet crash near Gaithersburg Airpark. The NTSB held a public hearing and released their final report on Tuesday, June 7. The probable cause of the crash is stated as follows from the report: *The NTSB determines that the probable cause of this accident was the pilot's conduct of an approach in structural icing conditions without turning on the airplane's wing and horizontal stabilizer deice system, leading to ice accumulation on those surfaces, and without using the appropriate landing performance speeds for the weather conditions and airplane weight, as indicated in the airplane's standard operating procedures, which together resulted in an aerodynamic stall at an altitude at which a recovery was not possible.*

**Dredging Project Completed at Lake Whetstone** - the park fully opened for resident use on Friday, June 10. The county's contractor finished the restoration of the parking lot and access road, repaired all of the green space and put back the volleyball court and play animals in the correct locations before vacating the property. Replacement trees will be planted in the fall.

**Budget 2017** - Department heads and their respective staff are preparing departmental 2017 Budgets. The EVP and CFO will be compiling the budget, including capital and reserve projects, for the Audit Committee's and Board's review at their joint meeting on Thursday, Aug. 25 at the North Creek Community Center, 20125 Arrowhead Road.

- The *Montgomery Village News* Letters to the Editor section is a community forum for Montgomery Village residents and/or property owners. In addition, at the Editor's discretion, the *Montgomery Village News* may print letters of appropriate interest to residents from others, including representatives of local schools, governments and businesses. Campaign letters are prohibited, except for Montgomery Village Foundation and Village homes corporation elections. The views expressed in the Letters to the Editor section are those of the authors of the letters and not necessarily those of the Montgomery Village Foundation (MVF) or its Board of Directors.
- The *Montgomery Village News* will make every effort to publish all letters received during the weeks prior to publication.
- Typed letters and e-mail must be received no later than 5 p.m. on the Monday prior to publication and distribution, while handwritten letters must be received no later than noon on the Friday, one week prior to publication. When a holiday occurs on a deadline Monday, Letters to the Editor must be received no later than noon on the subsequent Tuesday prior to the Friday publication and distribution.
- Letters must bear the writer's name, address and telephone number for verification purposes. The sole use of pen names, initials or the complete omission of a signature will eliminate a letter from consideration from publication. A request from the author to withhold the name or mark the letter anonymous will eliminate the letter from consideration.

Editor:

Whetstone faces a growing list of concerns that must be confronted. These challenges range from outsider parking currently in evidence on Whetstone Drive just below the Centerway entrance to door to door solicitors in Whetstone and the need to enforce the No Solicitor signs. And now another assisted living request has been received by the Whetstone Board.

This new request contains an alarming concern to Whetstone with respect to assisted living when it states: "The peaceful environment of Whetstone is ideal for such peace loving tenants according to the government agency that is interested in my

property." Just what is that government agency? On what basis does a government agency have a right or a mandate to target Whetstone for assisted living?

Driven by the new assisted living request, I urge the Whetstone Board to take the following actions:

1. Send a letter to the owner turning down the request for approval.

2. Immediately determine what government agency is behind this and direct the Whetstone lawyer to meet with the agency to ascertain their authority to target Whetstone in this manner and demand that the agency cease any further actions of this sort.

3. In the interest of full disclosure and since the homeowner letter locked in on the peaceful environment of Whetstone, the board should inform the homeowner and the government agency that the assertion of peacefulness is false in as much as a murder took place within a few hundred yards of the back door of the home within the past few months and that any assertion of peacefulness comprises a false claim.

4. Notify our Senator and Congressman and request action from their offices to put an end to government agency targeting of Whetstone.

## Community maintenance—universal trash reminders

Where there are people, there will be trash. With 40,000 residents in Montgomery Village, there are certainly opportunities for large amounts of trash to be created. And, for the most part, residents do their part in keeping their neighborhoods clean and free of excess trash. Unfortunately, there are instances where people ignore both community policies and county laws, exposing trash for wildlife and nature to do as they please, leaving our neighborhoods looking, well, "trashy."

There are both aesthetic and environmental reasons to keep your trash stored correctly. First is the obvious: trash cans lining a street ready for collection, or neatly stored other days of the week presents a tidy appearance. The uniformity of seeing trash cans with lids, and not trash bags piled up, keeps our waste to a visual minimum. Piles of trash bags look messy, and give visitors an impression that we are not proud of our community.

Environmentally, properly stored trash helps to eliminate vermin and pests such as vultures, rats and mice. Once these pests get to loose trash bags, they often open, spread and leave trash all over the neigh-

borhood. This can attract other animals as well, often inviting the chance for disease or unsafe conditions for residents, children and pets. Additionally, someone needs to clean up the mess. This is usually done by your trash contractor, but for a price above what your regular trash collection costs; this is association money that could be better spent on items in your community.

This also applies to dumping trash, or even leaving it on common property as "a convenience" to your trash contractor. In Montgomery Village neighborhoods, there are no common areas set aside for trash pickup (this does not apply to all condominiums or apartments). While it may seem like a good idea to have a central collection area, trash contractors are instructed to pick up trash from individual residences. Having an area filled with trash that is not on their prescribed route means an extra pickup, and therefore, extra cost. For large or bulk items, most trash contractors for Village residents allow several free pickups per year—all you need to do is make a simple phone call to schedule the pickup. Residents can see who their trash contractor is online

### DID YOU KNOW...

- Montgomery County (and most HOA trash policies) require that trash be put in a sealed, vermin-proof container?
- Bulk pickups can be scheduled with your trash contractor?
- It costs more assessment dollars to collect trash from anywhere other than in front of your home?
- Trash cans should be placed and removed per your community trash policy (times and days vary)?
- Most communities require storage of trash bins behind screening, in the rear yard or out of view from the street?
- Yard waste, including Christmas trees, should be trimmed, bundled and left for recycling, not with your trash?

## Navy Junior ROTC works with, within the community

The Navy Junior ROTC program at Gaithersburg High School (GHS), which also includes students from Watkins Mill, Rockville and Quince Orchard high schools, has just completed another successful and productive year. The unit, led by Captain James Kelley (retired) and Chief Marty McQuagge (retired), was comprised of 175 students taking the Naval Science elective course offered at GHS. Thirty-four of these cadets were graduating seniors, 17 of whom will either be enlisting in the military or attending college on ROTC scholarships.

The Navy Junior ROTC program was established in 1964, and its curriculum is taught by retired Navy, Marine Corps and Coast Guard personnel in high schools across the U.S. The JROTC unit at GHS has been named a Distinguished Unit for the past 25 years, an award presented to the top 30% of programs in the country. The JROTC program emphasizes citizenship and leadership development as well as naval topics such as naval operations, seamanship, navigation and history. Classroom instruction is augmented by community service activities, drills, physical

fitness competitions and visits to naval installations. The mission of the Junior ROTC program is to develop leadership and individual discipline, promote patriotism and responsible citizenship, and to provide information on military service as a possible career option.

The unit has participated in many community service events during the 2015-16 school year. These included providing color guard personnel for MCPS events, naturalization and citizenship ceremonies for the Department of Homeland Security and Veterans Day ceremonies for the cities of Gaithersburg and Rockville. The unit recently assisted the Rotary Clubs of Gaithersburg and Montgomery Village with placing the flags at Bohrer Park along Route 355 in honor of heroes for Memorial Day.

The cadets hold several fundraising events throughout the year to support the unit's

## Early summer news

At the June 14 meeting, the board of directors approved the FY2015 audit after a presentation by Howard Goldklang, CPA. Mr. Goldklang noted that Northgate is in good shape, and the audit was positive. Mr. Goldklang has more than 25 years of experience auditing homeowners associations and is greatly respected in the industry.

Other business included approval to remove 11 problematic trees throughout the community, funds for concrete repairs, drain cleaning, minor pruning and gator (water) bags for new trees in Williams Range.

Additional fire lane signs will be going up in some areas based on direction from the fire marshal. Please note there is a \$250 fine for violations, and vehicles can be towed without notice.

As stated in the last column (and obviously an ongoing problem), the board is asking if you see a resident putting out regular or bulk trash other than on the evening before pickup (or early on the pickup day), that you please report it to [NorthgateHC@comsource.com](mailto:NorthgateHC@comsource.com). You will remain anonymous. There continues to be a dumping issue in certain neighborhoods, and we need your help to resolve it.

Trash pickup in The Points and Overlea is on Mondays and Thursdays. Every other subdivi-

sion has pickups on Tuesdays and Fridays. Both regular and bulk trash should be placed out the evening before pickup.

If you need a bulk trash pickup, please place your items out on the following schedule:

**Thursdays** - Overlea and The Points

**Fridays** - Apple Ridge, Dorsey's Regard, McKendree I & II, Shadow Oak and Williams Range.

All bulk pickups must be placed curbside. Residents of Overlea and McKendree I & II must bring their bulk items to the curb. No recyclable items will be taken as bulk, nor will construction material generated by a contractor. If a resident places a rug or carpet out for bulk pickup it is acceptable. If a homeowner has a carpet or rug contractor replacing rugs or carpet in the home, the contractor is responsible for the removal of the carpet or rugs.

If your trash pickup is missed, call Potomac Disposal at 301-294-9700.

## Keep calm, but plan ahead (Stuff happens—are you feeling lucky?)

Risk can be defined as the consequences of actions (or inaction) despite uncertainty, and the potential for losing (or gaining) something of value.

We all make decisions in the face of risk throughout our lives, assessing risk for many activities on a daily basis. Suffice it to say, risks in or around our homes and property can have consequences ranging from a nuisance to life threatening. But the good news is that many risks can be anticipated, reduced or prevented.

In the realm of the risks associated with fire, rescue and emergency medical services, we are very fortunate to have the Montgomery County Fire and Rescue Service (MCFRS) with its career and volunteer members focused on assessing risk and planning for such eventualities throughout the county. Last September, the MCFRS released the 2016-2022 Fire, Rescue, Emergency Medical Services and Community Risk Reduction Master Plan. In addition to operational issues, this very detailed plan assigns risks (the probability of occurrence X consequences = risk) into four levels with numerous examples of "typical" emergencies at each level. And there are some surprises!

The MCFRS places great emphasis on helping us to understand, assess and reduce risks that confront all Stedwick residents, and has a very active and "user friendly" approach to public education and safety assessment through several outreach programs. These include programs for the general public and schools, as well as "in-home" programs designed specifically for caregivers, seniors and/or disabled residents. Some programs deal with very basic concerns, such as visibility of house numbers to locate you quickly in an emergency. Other emergency preparedness objectives emphasize more complex con-

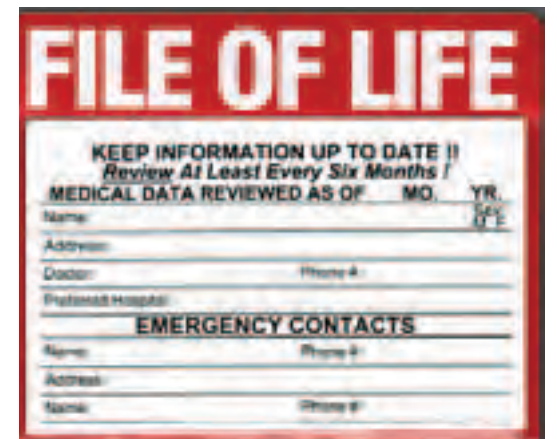
cerns and may benefit from a residential assessment.

Two examples are the home smoke alarm safety check and the "File of Life" program.

Residential smoke alarm requirements in Montgomery County have steadily evolved since the 1970s, when most homes in Stedwick were built. And while our older structures often do not have the latest in hardwired and interconnected alarm systems with backup, upgrading at little or no cost is possible.

Under the Smoke Alarm Installation and Home Safety Program, the MCFRS will visit your home and offer advice on where appropriate smoke alarms should be located and installed for free for high risk occupants including older persons, individuals with mobility, vision or hearing impairments or other disabilities. Maryland has updated the smoke alarm laws, and it makes good safety and legal sense to have the MCFRS visit and check out your situation. Of course, a primary fire safety rule is if there is ever a fire inside your home, get out, stay out and call 911 after you are outside.

Then there is the "File of Life." The "File of Life" is an easily identifiable, small red magnetic packet designed to be placed on or near the refrigerator, which contains basic health information such as allergies, chronic conditions, medications and other critical aspects of medical history. Applicable for family members of all ages, the "File of Life" is especially suited to the emergency requirements of seniors and those with serious medical conditions and/or disabilities.



Should you be in an accident, or have a medical condition which could leave you or someone in your home unable to communicate with emergency medical personnel following a 911 call, such basic medical information about you allows more immediate assessment, diagnosis of your condition and provision of emergency care in the home or by transport to an appropriate facility. In these situations, time—and good information—really is of the essence!

Designed to be regularly updated, the "File of Life" can contain other information which might be important in a medical emergency, such as location of documents about health directives, personal wishes for resuscitation or notification of others.

## Whetstone June board meeting notes

At its June meeting, the Whetstone board approved contracts for tree pruning in Lakeside, bike path repaving, repair of a portion of the lakeshore path and planting of Liriope to halt hillside erosion along the bike path near Centerway Road and Rhodes Way.

RFPs for tree removal and concrete repair have been sent out. Whetstone's Procurement Policy requires three bids, which are then evaluated and voted on by the board. These two RFPs will be considered at the July meeting.

### BALLOTS ARE DUE!

Ballots for amendments to Whetstone's covenants have been mailed out. At its June meeting, the board was advised that close to 100 ballots had been sent in.

If you have not done so, please mark your yellow ballot and return it in its postage-paid envelope. Be sure to print your name and address, and sign the envelope (not the ballot!) where indicated on the front of the envelope. **Ballots are due back by 5 p.m. on Tuesday, Sept. 6.**

### RISER REPAIR

The board approved a 1-year easement for use of the North Dock paved parking lot and access road so that Montgomery County can make urgent repairs to the trash rack and riser (outfall) in Lake Whetstone.

### IVY AND BAMBOO

Love the trees. Hate the ivy. Back in the day, English ivy was considered an elegant solution for hillside erosion and for areas that didn't receive much sun. However, when English ivy grows up trees, it

kills them. If you have a street tree with ivy on it, please remove the ivy. You can do this by simply cutting the ivy about 3 feet up the tree. As the ivy dies, it will fall off the tree. Ivy around the base of a street tree should also be removed.

Another invasive plant is bamboo. It rapidly spreads from private property to community green space and is very difficult to eradicate. It overtakes trees, ornamental shrubs and grass. If you have bamboo growing on your property, please cut it down and then use weed killer on what remains. The board is spending thousands of your assessment dollars removing bamboo from community property where it does not belong.

### MORE DEER GUARDS

If you have seen black plastic cylinders around recently planted trees and wondered what they are, they are deer guards. Volunteers are placing them around many of the newer trees in areas where the deer are most prevalent. The deer have killed one Maple and damaged a Cherry tree. It is hoped that the deer guards will protect the trees until they are more established.

## North Village June board meeting

A meeting of the North Village Board of Directors was held on Thursday, June 16. The board treasurer presented the most recent financial data ending May 31. So far this year, we are showing a net loss of almost \$28,000 due to the huge snow removal costs that were more than three times what had been budgeted. But the good news is that our accounts receivable is running \$30,000 lower than last year and our operating cash is at a comfortable level.

Following the financial report, the committees gave their status reports. The Budget Committee reported that the board must start planning the budget for next year. The board agreed to hold a budget meeting in early August to begin the process, but they could not settle on the date at last week's meeting. We will report the date in our next article.

The chairman of the Maintenance Committee reported that there are a number of trees in the community that need attention. She said that the committee has developed a color code that will be used to mark the trees for either removal or pruning. She mentioned that the recycling buckets that were placed in Picton are being used by the residents, and the pet stations are heavily used and being kept stocked with bags.

She also reported on a number of incidences in which trash, furniture and building materials have been dumped on common property. Residents must be aware that such dumping costs everyone money. Hundreds of your assessment dollars have been spent cleaning up furniture and trash that could have been removed

for free by calling our trash contractor, Potomac Disposal, at 301-294-9700 and arranging a pickup. The board will be increasing their monitoring of the areas where dumping is prevalent, and charging the culprits for cleanup costs. We ask residents to report any dumping by calling our community manager at the number listed at the end of this article. Dumping is illegal, and the Montgomery County fine for dumping can be as high as \$500.

It was mentioned that there will be a Community Shred Day and Electronic Recycling Event on Saturday, June 25 from 10 a.m. to noon at 402 King Farm Boulevard, Rockville. This is in front of the King Farm Long and Foster office. Along with documents to be shredded, you can bring your used working or non-working electronics such as TVs, appliances, computers, printers and basically anything that plugs into the wall. There will be a team and truck on site to load and take them away to be recycled—for free.

The Public Safety Committee reported that all the street lights have been repaired and are now working except for the notorious number 1, which continues to elude the repair crews. That light has been out for over 1½ years.

The Capital Improvements Committee reported that an additional planned project this year is the painting of all the street lamp posts. Over

time, the paint on these posts has deteriorated. They will be painted black, their original color.

Other capital projects this year were approved for funding. Management presented three proposals for the striping of parking spaces and painting of curbs in Picton. The board reviewed the proposals and voted to select the bid from Chamberlain Contractors Inc.

Management presented a proposal from Master Fences for replacing the fence that separates Picton from the Pepco tract. The board voted to tentatively accept the proposal, but asked management to seek other bids and consider one with a lower cost, including painting. The board selected the option for a 5-foot-high, straight-line fence to replace the existing fence which was originally built not in a straight line to accommodate trees, most of which have been removed.

## Middle Village Parking Policy revision approved

by the Middle Village Homes Corporation

The Middle Village parking policy revision was discussed with the community at the May board meeting and was approved by the board of directors. The revised policy provides each home with a one additional parking tag (giving each home a total of three parking tags) which can be used in the homeowner's reserved parking space or any unmarked space. All vehicles parked overnight in the Middle Village community will be required to have a parking hang tag or they will be immediately towed. The policy will go into effect in August. One additional parking tag can be purchased annually for \$600 starting in December.

If you are delinquent on your home owner assessment fees, the previous rule of losing your reserved space, in addition to not receiving the third parking tag, will still apply. The reserved policy is available to view on the Com-

Source website via Sourcelink. Further information will be provided in the next few weeks regarding the distribution of the additional parking tag and the start date for the enforcement of the overnight parking permit policy.

### STORM DRAINS

There are numerous storm drains located along the curbs throughout the community. We have recently had to excavate a storm drain due to a clog filled with debris. This clog prevented water from flowing through the drain and flooded the surrounding parking lot and homeowner properties. Please do not dispose of any items in the storm drains other than water! Placing an item such as a water bottle in the

drain may seem harmless, but it can be the start of a very costly problem, which can translate into increased assessment fees.

Remember, bottles, paint cans or hazardous materials such as paint, oils, gasoline, etc. should never be placed in the storm drains. Help keep our community water system flowing efficiently and protect your property from flood damage.

### TRASH

Trash continues to be an issue in our community. Scheduled trash removal is on Tuesday and Friday each week, and recycling collection takes place on Wednesday. Before homeowners/tenants place bulk trash outside, they must contact Potomac Disposal at 301-294-9700 to schedule a pickup. Do not place any trash, including bulk trash, out prior to the pickup days of Tuesday and Friday. If you see a resident dumping bulk or loose trash and you know their address, you can report them to ComSource anonymously.

It is the responsibility of each resident to place their trash can in the appropriate location for pickup and to collect their trash cans/recycling containers and place them back on their property on the day that trash/recycling is collected.

Unmarked trash cans and recycling containers are often left in common areas all week. This attracts rodents, and has a negative impact on the appearance of our community and our property values. Any trash cans or recycling containers that are not marked with an address will be collected and disposed of.

This committee meets on an as-needed basis in the Council Office Building. Its members are made up of various citizens and airport user groups and discuss airport

issues including noise, flight patterns, Airport Layout Plans, Airport Environmental Assessments, infrastructure projects and changes, and other matters. At present, there are 16 members of this committee."

Please attend and encourage others to attend as well, to ensure that the surrounding communities' continued concerns and requests are recognized.





Kinds of Marbles

-  Agates or Aggies – Made of agate.
-  Alleys or Allies – Made of Alabaster.
-  Benningtons – Like spotted Bennington pottery.
-  Bumboozers – A large marble of agate or glass.
-  Cat's Eyes – Clear marbles with colored blades.
-  Clearies – Clear glass marbles.
-  Clouds – Colored flecks of glass like clouds.
-  Commonneys or Commies – Common marbles.
-  Corkscrews – Two or more colors in spiral designs.
-  Glassies or Puries – Clear, colored glass marbles.
-  Immies – Glass marbles that imitate agate.
-  Milkyies – Milky white marbles.
-  Onion Skins – Many swirls, resembling an onion.
-  Peewees – Small marbles.
-  Steelies – Ball bearings used as marbles.
-  Sulfides – Clear marbles which have clay figures inside.
-  Swirls – Could be handmade or machine made. The handmade ones have bands or strands running from end to end.

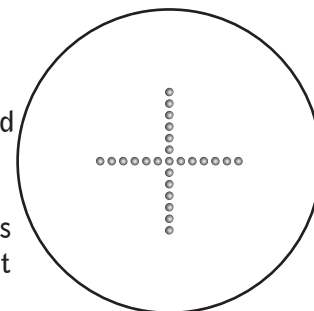

Marbles are small balls usually made from glass or plastic used to collect or play a game called...what else? Marbles. Collectible marbles can be as small as 1/30 inch to over 12 inches in diameter.

Marbles Game—Ringer

This is the game played in tournaments.

Setup - Draw a circle that is 10 feet across and put 25 marbles in the center. The marbles should form a cross, and be spaced 3 inches apart.



Starting with the first player, each person shoots from anywhere outside of the circle, trying to hit a mib (the marbles you shoot at) out of the ring while keeping the shooter inside the ring.

If a player's shooter misses a mib, or doesn't hit any out of the ring, the turn is over and they pick up their shooter.

If a shooter hits a mib out of the ring but the shooter also rolls out of the ring, they keep the marbles that rolled out of the ring. The turn is over, and they pick up their shooter.

If the shooter hits a mib out of the ring and stays inside of the ring, they can shoot again. The player keeps all of the marbles that they hit out of the ring, but they have to shoot from wherever the shooter ends up.

On each new turn, players can shoot from anywhere outside of the circle. Play continues until all the marbles have been shot out of the ring.

Whoever collects the most marbles is the winner.
