In memoriam – Richard “Dick” Wright



“Dick” Wright. Dick and his wife Teresa were early residents of Montgomery Village, but didn’t just settle on making their home here; they helped make Montgomery Village home for generations of families, including three generations of their own family.

After a job offer from the National Bureau of Standards (now NIST) brought the couple to the area in the early 1970s, they fell in love with the amenities Montgomery Village offered for their family, bought a house and spent almost 50 years helping shape the community.

Late last week, Montgomery Village lost one of its longtime supporters and community advocates, Richard

During that time, Dick served on the Patton Ridge and Montgomery Village Foundation (MVF) boards of directors—as both director and in several stints as president on each board, serving on the latter for 27 consecutive years—as well as chairing or co-chairing many MVF committees. He used his calm leadership style, keen understanding of Village, county and state affairs, combined with his quick wit and gentle nature, to lead the community. Dick was an advocate for diversity and equal representation for all in the Village; he lived with a conscious commitment to making the Village a better place.

But his service to the community was not just in contributions to Village boards and

committees. As a family, Dick and Teresa welcomed new to the area Latino families into their home to acquaint them with the schools, community, amenities and services available to them. Dick was also an advocate for youth, heading up the SHARP program effort in the Village in the early-2000s and participating in and chairing many important continuing education opportunities on climate change and sustainability across the country and around the world through the American Society of Civil Engineers.

Dick also enjoyed the beauty of the entire community and could often be seen riding his bike throughout the Village. He had particular routes, but liked to survey the

surroundings, get exercise and give a friendly wave to fellow residents during his almost daily rides. No matter what he found on his ride or in life, Dick approached it with deep intelligence, passion and an infectious smile.

North Creek Pool concepts presented to MVF Board

Representatives from Scheibel Construction presented the two concept plans for the North Creek Pool renovation at the May 23 Montgomery Village Foundation (MVF) Board of Directors meeting. Concepts shown to the Board incorporated features and feedback based on an earlier presentation to the Recreation Committee.

Gus Muell from Scheibel Construction, Greg Gilbert from Bignell Watkins Hasser Architects and Jake Huess from Aquatic Design Group described the proposed changes to the pool layout and bathhouse, noting that the plans shown were only conceptual and specifics would be negotiated at a later date. Muell said the goal was to bring the building and pool in line with community wants while balancing county standards and codes.

Gilbert outlined the details of the bathhouse, noting that proposed renovations include a totally new layout, including a family restroom; an expanded mechanical room; a new storage shed; exterior lockers and showers; and an elevator for accessibility. The existing footprint of the building would remain, and be slightly expanded on the back side to

incorporate the interior plumbing fixtures.

Huess then debuted two concepts for the pool design, saying that recent feedback from residents, the Recreation Committee, swim team representatives and staff had been incorporated into the presentation. Both concepts include a children’s wading pool or splash pad, beach entry, lap lanes, the possibility of a diving well and a signature feature—a 20-foot tall, 140-foot ride water slide.

Concept A is competition swim heavy, incorporating both 50 and 25-meter lap lanes. This option also allows the most flexibility for other recreational add-ons such as in-water inflatables, volleyball, basketball, rock walls, etc. that can enhance the functionality of the space. It also provides both a regular course and a long course swim meet option with the lap lanes, as well as reserving the greatest number of useable lap lanes while other portions of the pool are in use.

Concept B retains the 25-meter lap lanes and has a more aesthetic beach entry, as well as a wet sunbathing area similar to Peggy Mark Pool. While this pool is 1,500 sq. feet

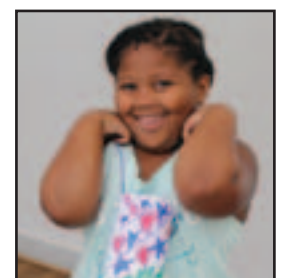

1. Mr. Dyer moved to approve the minutes of the regular meeting held April 25, 2019 as presented. The motion was seconded and passed (5-0-1); Ms. Bort abstained.
2. Ms. Ayres moved to approve the notes of the MVF Board Retreat held May 4, 2019 as presented. The motion was seconded and passed (5-0-1); Mr. Dyer abstained.
3. Mr. Dyer moved to accept the Action List as presented. The motion was seconded and passed unanimously.
4. Mr. Dyer moved to reappoint Melanie O'Brien as Chair of the Communications Committee. The motion was seconded and passed unanimously.
5. Mr. Webb moved to appoint Karen Neilson as Chair of the Recreation Committee. The motion was seconded and passed unanimously.
6. Mr. Dyer moved to approve the purchase of 13 Dell OptiPlex 7460 All-in-One, 4 OptiPlex 5060 SFF, 4 Dell Latitude 5480 laptops/docking stations and 6 monitors from The Dresner Group for \$26,894.07 with a 10% contingency for a total cost not to exceed \$29,583.48, with the funds to come from reserves. The motion was seconded and passed unanimously.
7. Mr. Dyer moved to authorize the EVP to negotiate a contract for Concept A with Scheibel Construction for design/build services for the North Creek Pool and Boathouse renovation project. The motion was seconded and passed unanimously.
8. Mr. Dyer moved to appoint Jamie Kumpf Kendrick to the Recreation Committee. The motion was seconded and passed unanimously.

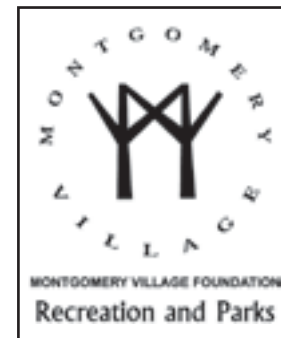

Hurley Park to get new paths, lights

On the heels of the playground replacement at William Hurley Park, other park infrastructure is in need of replacement. Path lights in the park were scheduled for replacement in 2018 and were to be done in coordination with the playground replacement. Additionally, the path itself is aged and in need of major work; it currently has drainage issues, tree root damage and cracking over the majority of the path.

Bids for both projects were solicited from qualified contractors and were awarded at the May 23 Montgomery Village Foundation (MVF) Board of Directors meeting. M.R. Electricians was selected to replace the 8-foot old globe light fixtures with new 12-foot LED fixtures for a replacement cost of \$14,257 from Reserves.

Total Asphalt, LLC was selected for the path project, which will also include re-striping the basketball court. Problem-causing roots will be removed, followed by application of deep patches and a 1.5"

asphalt overlay to the path. The Board awarded the bid for \$18,725 from Reserves.

OTHER AGENDA ITEMS

In committee affairs, two committee chairs were reaffirmed and a new Recreation Committee member was appointed. Melanie O'Brien and Karen Neilson were respectively reaffirmed to chair the Communications and Recreation Committees. Village resident Jamie Kumpf Kendrick was also appointed to serve on the Recreation Committee.

The Board also approved the purchase of computer replacements for the MVF Office, from Dell, through MVF's IT contractor. Computers are replaced every five years, with expenses coming from Reserves. In order to stay ahead of the Windows 7 operating system end of support, 2020 replacements were also added to this year's purchase, totaling \$26,894.07.

Finally, the Board reviewed concept plans for the renovation of the North Creek Pool and Bathhouse. Following a presentation by Scheibel Con-

struction and discussion of the proposed concepts, the Board authorized the EVP to negotiate a contract for the combination 50/25-meter pool design and desired features (see article on page 1 for full details).

PRESIDENT'S REMARKS

Board President Glenn Gargan noted that Architectural Review Board (ARB) member Andrew Walker had recently resigned after several years of service on the committee. Although Walker was not able to attend the meeting, he was honored with a Community Service Award for his time on the committee.

Gargan thanked members of the community, including fellow Board members, for their volunteered time and dedication to the community. He went on to say he believes the MVF staff continues to do a great job advancing the Village and keeping resident concerns at the forefront.

EVP REPORT

EVP Dave Humpton said that the May 4 MVF Board

Retreat was productive. He thanked the Board for their input during the session, noting that there were a number of items discussed that would be relevant for either budget or long-term planning.

Humpton also reported that the next census will soon be upon us, and the emphasis this time around is a complete count, making sure forms are filled out by all residents. He said that MVF will be helping spread the word and assisting in the upcounty efforts to reach all segments of the population in our area.

TREASURER'S REPORT

In the absence of both the MVF treasurer and CFO, EVP Humpton gave the financial report for the month of April and the year-to-date (YTD). Humpton reported that overall, MVF had higher than expected Investment, Capital Contribution Fee and Village-wide Special Event revenue, slightly offset by lower than expected Advertising Revenue.

He noted that both Personnel and Operating costs were

running favorable to the budget, as well as Net income for the month at about \$200,000, which was approximately \$48,000 ahead of the budget. Additionally, Total Revenue and Total Operating Expenses were reported as \$3.2 million and \$2.2 million, respectively, both favorable to the budget. Contributions to Reserves were made as prescribed.

With MVF's \$9.7 million in Cash and Investments and \$1.99 million in Undesignated Reserves, Humpton remains confident about MVF's continued excellent financial position.

NEXT MEETING

The next MVF Board of Directors meeting is scheduled for 7:30 p.m. on Thursday, June 27 in the North Creek Board Room, 20125 Arrowhead Road. The meeting begins promptly at 7:30 p.m. with Residents Time. Residents are invited and encouraged to attend. The meeting agenda and information packet will be available online at www.montgomeryvillage.com the week of the meeting.

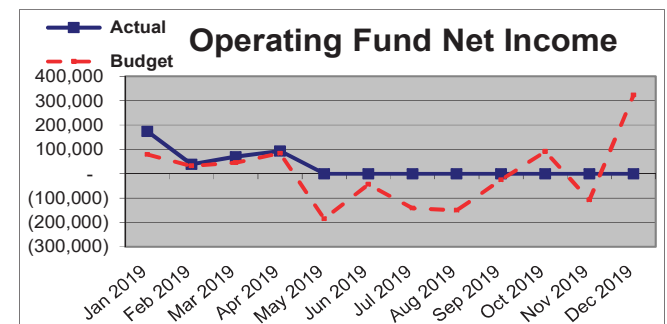

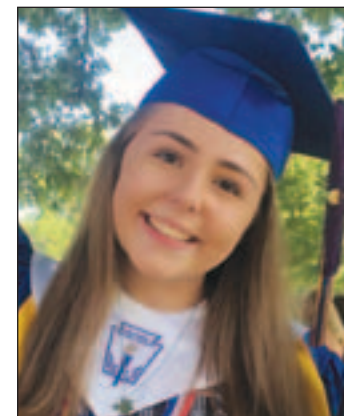

The Montgomery Village Foundation (MVF) once again joined the Watkins Mill and Gaithersburg High Schools' Parent Teacher Student Association (PTSA) to continue the MVF Scholarship Fund, now completing its 28th year. Since the program's inception in 1991, scholarships amounting to over \$50,000 have been awarded to Village high school seniors. The amount available for each school is entirely determined by the amount donated by Village residents.

MVF Board approved guidelines for the awards require that the applicants be Montgomery Village residents who have actively participated in and been leaders of community or civic activities, clubs or organizations and who have demonstrated high scholastic achievement.

NANA ACHIAA OSEI TUTU

Nana Achiaa excelled academically throughout her high school years, while participating actively in extracurricular clubs and sports, including being editor-in-chief of the school newspaper, counselor at March to the Mill and participating in girls' varsity soccer and varsity track and field. smaller, it retains the swim team functionality and adds some resort feel.

The Board asked questions regarding additional features, the main purpose of this pool and facility and reviewed recommendations from both MVF

staff and the Recreation Committee. After discussion and consideration, they authorized the EVP to negotiate a contract with Scheibel Construction for design/build services on Concept A, the 50/25-meter combination pool.

Staying Aware in the Village

The following is information taken from the Recent News Summaries of the Montgomery County Police Department and is not a complete listing of every incident.

RESIDENTIAL BURGLARY

Park of the Month: Edward A. DeSimon Recreation Area

Nestled off East Village Avenue, residents and visitors can find Edward A. DeSimon Recreation Area, 8600 East Village Avenue, often referred to as "Ed DeSimon Park." The park is named after the late Edward DeSimon, who worked for Kettler Brothers Inc. for 35 years until his retirement in 1992. DeSimon was responsible for community site grading; he later became manager of land development, and then served as senior vice president. He can be seen pictured with Clarence Kettler on the cover of the "Images of America: Montgomery Village" pictorial history book.

This 8.27-acre recreational area is a hidden gem in the East Village area. The park contains a playground – which was replaced in 2013 – a pond, four tennis courts and paved paths throughout the park. In addition to these amenities, there is large open green space – a great place to toss a Frisbee or football around.

The park's most notable feature is probably the 2-acre pond. This pond is a great place for wildlife viewing and fishing. The pond at Ed DeSimon Park is home to Montgomery Village Foundation's Fishing Rodeo. This year the rodeo is scheduled from 9 a.m. to noon on Saturday, June 15.

This event is appropriate for children ages 3 to 15 and is a great way to learn the basics of fishing. The event itself is free, and participants are welcome to bring their own rods. There is a \$5 fee for those that need to rent a fishing rod during the event. There are a limited number of rental rods available, so please plan to register in advance if you need to rent a fishing rod.

Whether you prefer wildlife watching at one of the many benches around the lake, enjoy playing a morning game of tennis or watching your little ones play on the playground, this park has something for everyone!

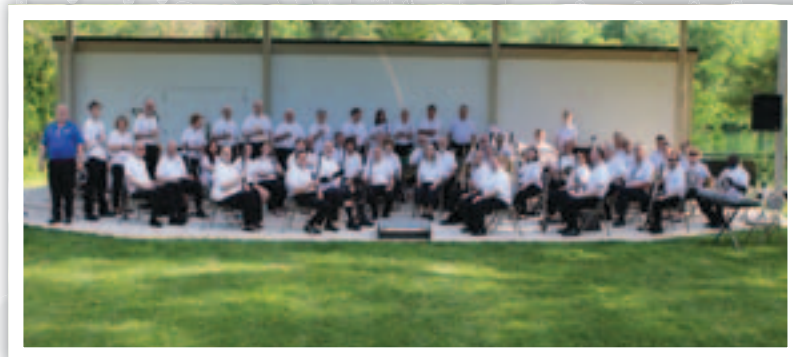

County-assisted child care program

Do you know someone who needs help with child care costs? The Working Parents Assistance Program, a child care subsidy Program funded by Montgomery County Government, may be able to help. Caseworkers determine eligibility based on income.

Once approved, clients receive a voucher covering a period of months for each eligible child. The vouchers are then turned in to licensed care providers.

For more information or to apply, call 240-777-1155, apply in person at 7300 Calhoun Place, Suite 700, Rockville, or visit www.montgomerycountymd.gov/wpa.

The following is a list of documents that must be returned with the application to make it complete. Please note that other documents may be required in order to make the eligibility decision:

- Proof of Montgomery County residency, such as driver's license with cur-

rent address, lease or utility bill.

- For non-U.S. citizens, eligibility is based on citizenship of the child(ren).
- Social Security Numbers
- Proof of identity, such as social security card, birth certificate or any unexpired government issued document such as a passport or driver's license.
- Pay stubs for the most recent consecutive four weeks; or if a new job, a letter on company letterhead which includes start date, rate of pay, number of hours and work schedule.
- An official class schedule if attending high school or undergraduate college. A receipt to verify tuition paid is also required for undergraduate college students.
- If enrolled in a training program, a letter from the program's staff on their letterhead that confirms enrollment, the start and end dates and the actual days and hours of training.

- An award letter if receiving SSI or SSA benefits from the Social Security Administration.
- Copy of your most recent tax return - federal form 1040 with W-2s.
- Verification of income from child support payments, either proof of court ordered or an official WPA voluntary child support must be provided from all absent parents, along with proof of address and checks.
- Official proof of any additional income.
- For two-parent households, documents are required for both parents.

ARCHITECTURAL STANDARDS

Tips to avoid architectural violations

Being in compliance with architectural policies and criteria is not as difficult as you may think. The goal of the Architectural Standards staff is to help protect Village property values by preserving a harmonious look on residential homes and enhancing the overall appearance of Montgomery Village. So, what can a homeowner do to avoid architectural violations?

• **Apply before you buy!** Homeowners are required to apply and receive approval for any exterior modification that is being made to their property, before any work begins. It's free to apply and we turn decisions around in 10 business days on average, depending on the complexity and completeness of the application. If modifications are made without prior approval, you will be cited for an architectural violation, charged a \$25 review fee, and the modification will be reviewed for compliance. Please visit www.montgomeryvillage.com/pir to apply online, and learn more about the application process by visiting www.montgomeryvillage.com and searching keyword "Quick" to access our Quick Reference Guide to Applying for Property Modifications.

• **Set up an online account.** Setting up a free online account will allow you to access the architectural criteria, view your external property profile, stay up to date on the status of your application and access a number of other features specific to your property. Creating an account is simple: visit www.montgomeryvillage.com and locate the "Login/Join" link on the top right of your screen. Next, click "Create a New Account" and enter your e-mail, name, address and preferred communication style. Then just sit back and relax while we verify that you're not a robot! The verification process can take up to 5 business days, but hold tight because once your

account has been approved, you will receive another e-mail containing information about how to log in, set your password and other details.

• **Review the architectural criteria and guidelines.** Each subdivision in Montgomery Village has its own set of architectural criteria that outline what features must be retained on homes and what modifications are acceptable. Once you have an online account, you'll be able to access the criteria for your community. If you don't have an account, contact our office and we can provide you with a copy. The Village-wide architectural guidelines are available on the Architectural Standards page of our website and provide guidance on a number of potential property modifications that are applicable to all Village communities. Please be advised that architectural criteria and guidelines are reviewed and updated as materials and colors change over time.

If you do receive an architectural violation letter, you must make all required corrections by the specified deadline, or submit your appeal within 30 days. The homeowner must sign and return the "Notice of Compliance" section of the notification and include photos of the corrected items. These items should be sent to the compliance specialist assigned to your community by mail or e-mail. If you have any questions or concerns about a violation letter, please contact the compliance specialist who sent it to you—their contact information will be at the bottom of the letter—or call 240-243-2364.

Remember that the best way to avoid an architectural violation is to reference the architectural criteria and apply for any exterior modification. If you are unsure if you need to apply for a modification, call our office at 240-243-2364. We are here to help!

Kids at Play

Spring is here, and that means children will be out running and playing. Drive slowly through our community, and keep an eye out for children crossing streets, playing in the parking lots, riding bicycles and running from between or behind cars. Safety is everyone's responsibility.

STORM DRAINS

There are numerous storm drains located along the curbs throughout the community. Please do not dispose of any items in the storm drains! Placing an item such as a water

bottle in the drain may seem harmless, but it can be the start of a very costly problem, which can translate into increased assessment fees. Remember: no bottles, paint cans, hazardous materials such as paint, oils, gasoline, etc. are ever to be placed in the storm drains. Help keep our community water system flowing efficiently, and protect your property from flood damage.

TOWING

The current Middle Village Parking policy states:

"All vehicles parked overnight in the community are required to display a MVHC parking tag/permit or they are

subject to immediate towing. For purposes of these Rules, overnight is defined as parking a vehicle in MV anytime between 11 p.m. and 5 a.m."

"Parking tag/permit must be clearly/properly displayed, on the driver's side, facing the front windshield, on vehicles parked in a reserved parking space, or parked in the community overnight. Tags/permits can be hung from the rearview mirror or taped to the driver's side dashboard or front windshield, front side facing toward the windshield."

"Failure to properly display the current year's parking tag/permit will lead to immedi-

ate towing - even if vehicle is parked in the appropriate reserved parking space. No warnings or notifications will be issued."

"No commercial vehicles or trailers of any type, campers, or recreational vehicles

shall be permitted to remain overnight on either the property of a private dwelling unit or on the community-owned property within Middle Village. For purposes of these rules, overnight is defined as parking a vehicle between 11 p.m. and 5 a.m."

"Commercial vehicles include vehicles with any type of writing or printing (letters, words, pictures, insignia, etc.) identifying a firm, organization, service, product, etc., of any kind, type or description. All vehicles carrying ladders, pipes, ladder racks, truck-loaded tools or truck-loaded tool boxes, etc., will be considered commercial. Vans used for delivering, storing or transporting goods or cargo are also considered to be commercial vehicles and are prohibited from remaining overnight in the community. Police vehicles are exempted."

"No commercial vehicles (including commercial pickup trucks) shall be permitted to remain overnight in the community. Pickup trucks must not have ladder racks, truck-loaded tools or truck-loaded toolboxes. Further, pickup trucks may not park overnight in the community with any cargo, items or material of any kind in the truck bed (landscaping debris, tools, boxes, trash, equipment, etc.) that exceeds the height of the truck bed sides or that extends beyond the tailgate. Pickup trucks with cargo that meet this description will be considered commercial vehicles and are not permitted to park in the community overnight. Violations are subject to immediate towing."

ASSESSMENTS

We live in a community that requires every home-

owner to pay assessment fees. Assessments are used to pay contractors for landscaping, snow removal, trash collection, collection of illegally dumped trash, lighting, repairs on community property, etc. If you are a homeowner, you were provided with this information during closing.

Reminder: Assessments are due to be paid monthly. Your payment must be received by ComSource on or before the 15th of the month to avoid late charges. Your regular payments allow us to continue providing services to our community.

Homeowners who are delinquent with their assessment payments must pay their past due balance in full or make arrangements to pay them. The first step to making payment arrangements is to contact Delphine Matthews at 301-924-7355 or dmatthews@comsource.com.

If a tree falls, who removes it?

East Village has a lot of trees. And they fall down. Since February, several strong windstorms have swept through East Village and knocked down quite a few of our trees. After every storm, East Village Community Manager April Steward and the Brightview Landscaping manager immediately inspect the community looking for damage. They also respond to residents who report fallen trees.



When a tree comes down, residents sometimes ask who is responsible for its removal? It depends on who owns it.

In East Village, there are several possible property owners. Trees could be the responsibility of homeowners, East Homes Corporation or Montgomery Village Foundation, depending on which piece of land it is on. Trees are expensive to remove and can cause considerable damage, and each property owner has to follow the laws pertaining to property rights and responsibilities.

Following are some examples. If you have a tree on your property that falls down entirely within your property, you're responsible for its removal (check with your Home Insurance Policy). However, if your tree falls on your neighbor's property, you're only responsible for the portion of the tree on your property. Your neighbor pays for the portion of your tree on their property. The same holds true if your neighbor's tree falls on your property. You have to pay to remove what is over your property line. If there is property damage in any of the above situations, contact your insurance agent.

As property owners, East Village and MVF follow the same rules and laws. If a tree on East Village or MVF property falls on homeowner property, East Village or MVF is responsible for removing the part of the tree on the common property held by either entity, but not what falls on private property.

East Village conducts regular monthly inspections covering trees and many other items.

If a tree is noted to have died or is leaning at a certain point that may cause damage, it'll be removed after a joint maintenance committee agreement and decision. Homeowners sometimes request that trees next to their house, but on East Village property, be trimmed or removed. The maintenance committee looks at each situation and determines if a tree is unhealthy or has died or appears to be leaning and may fall. Limbs that are too close to roofs of homes will sometimes

be trimmed back.

It should be noted that there is a tree trimming schedule, and each neighborhood has its trees trimmed on a three or four year cycle.

ANNUAL PICNIC IN SEPTEMBER

Come and meet your neighbors by attending the Annual East Village Picnic scheduled from 1 to 4 p.m. on Sunday, Sept. 22 at Lake Marion Community Center, 8821 East Village Avenue. We will be on the deck overlooking the lake, and food and refreshments will be provided. In the past, a DJ has rocked the deck with music with kids and adults joining in for fun dance contests. Face painting or other children's activities have always been popular. Plus, many local and state elected officials have attended. It's a chance to bend their ear and voice your concerns to EVHC board members as well.

TRASH SHOULD BE SEALED

Finally, a friendly reminder that all trash should be stored in tightly sealed containers, then put on the curbside on your collection day. It's the law, so please follow it. Trash pickup is every Tuesday and Friday, while county recycling is every Friday; when there is a national or state recognized holiday during the week, recycling will slide one day and be picked up on Saturday.

STEDWICK SIGNALS

If parking matters to you, read this

by the Stedwick Board of Directors

Parking in the Stedwick community continues to be a significant problem. The Stedwick board hears from residents with complaints about the parking "situation" at each monthly meeting. Recently, in some of our neighborhoods, parking issues have risen to confrontational or violent situations which have demanded police intervention.

To address some of the problems, our security service has been more aggressive with the tagging of stored vehicles (those that remain unmoved in 14 days). There has been an increase in the number of vehicles towed from our streets for several types of violations. In addition, the maintenance staff is removing traffic cones and other items being used to improperly or illegally reserve parking spaces.

Given the increasingly difficult parking situation, the Stedwick board is considering more aggressive parking policies. For example, restricting each household to a maximum

of two or three parking permits; denying parking permits to households in arrears on assessments; towing vehicles failing to display a permit; or charging a substantial payment for the replacement of "lost" permits.

We are also reviewing policies that have been implemented in other areas of Montgomery Village. The board is aware that several of the revised or additional policy alternatives and restrictions would likely result in additional administrative coordination and costs. Since there is potential inconvenience or distress to many of our residents, the board will be balancing the possible options carefully.

The Stedwick board is hopeful that the review and revision of our parking policies can be completed over the next few months. It is the intention of the board to keep the Stedwick community informed by continuing to request your active participation by speaking with us during residents time at the beginning of each of our monthly meetings (on

the third Wednesday of each month), or by residents attending and participating in a planned community forum on the parking issue.

The Stedwick board invites your comments—either in writing or by presentation—during the residents time portion at the beginning of every monthly Stedwick Board meeting. Meetings begin at 7:30 p.m. on the third Wednesday of each month at Stedwick Community Center, 10401 Stedwick Road. The next meeting is scheduled for 7:30 p.m. on Wednesday, June 19. Safety first!

Kids should be able to go outside and enjoy their neighborhoods, but not without knowing how to stay safe. Warmer weather and longer hours of daylight have the children of South Village wanting to go outside and enjoy themselves. Parents can help kids stay safe by going over some basic rules and safety tips. Please take the time to help your children understand what it takes to stay safe and play respectfully in all of the South Village neighborhoods.

South Village streets and county roads aren't playgrounds, and is not recommended that kids use them as such. The periods of greatest risk are the hours just before and after sunset. During these periods, visibility is limited and a driver's depth perception is reduced by low light levels. Encourage children to stay alert at all times and supervise your children while they play.

If you do allow your kids to play in the street, please follow a few of these common sense safety tips:

- Stop all play when a vehicle is spotted; move to the side of the road and resume play only after the vehicle has passed.
- All evening play clothes (especially jackets, coats and wind breakers) should have reflective cloth strips. So should bikes, helmets and backpacks.
- Bike riding should be specifically monitored, unless the bike has been equipped with reflectors, head lamps safety features. Supervise your children while they ride.
- Teach kids at an early age to look left, right and left again before crossing the street. Then remind them to continue looking until safely across.
- Supervise games with soccer balls, footballs and basketballs. These toys can damage cars, windows or even cause your child to dart into the street without looking.

It's best to play on sidewalks, open grass areas or paths. Take care to cross at street corners, using crosswalks and children under 10 should cross the street with an adult.

You are responsible for the appropriate and adequate supervision of your minor children in the community. Let's continue to work together and keep South Village an awesome place to live and grow up! Please continue to watch for cars and take care not to allow damage of your neighbor's personal property. Residents and their children should respect and take care to preserve and protect all trees, shrubbery, landscaping and other portions of community property.

Update on projects

Howard Goldklang from Northgate's auditing firm presented Northgate's 2018 audit to the board at the May meeting. Mr. Goldklang gave the association a clean bill of health and noted we were under budget for FY2018.

Also at the May meeting, the board approved funds to repair the paths in The Points. We are working out some details with the contractor before the work can start.

McFall & Berry was awarded a contract to re-grade, re-sod and rip-rap an area along Maple Leaf Drive. The work will solve an erosion problem.

Mead Tree was awarded a contract to remove three rotting pines on Grazing Terrace.

On the subject of trees, Northgate has a substantial list of trees that must be removed. They are prioritized for removal by a certified arborist, not by the board, and not by our manager. If you have been told a tree will be removed, it will be. Please be patient. Every time there is a storm, the tree removal list changes in order to handle emergencies.

Northgate is not removing trees because someone does not like them. The association utilizes a professional to tell it the condition and status of com-

munity trees. Demanding removals outside the professional recommendations we receive is not helpful. Removing trees is very expensive and the board works within the budget.

The board is aware that the benches in Apple Ridge need replacing. The work will be done. We are working on options now. Thank you to those who keep us updated.

On to trash, our least favorite subject. Buy a trash can, put your bags of trash in it. Every household has two trash pickups each week, and residents can put out bulk trash on the last pickup day of the week.

Regular trash pickups for Overlea and The Points are on Mondays and Thursdays. All other sections have pickups on Tuesdays and Fridays (McKendree I & II, Apple Ridge, Shadow Oak, Dorsey's Regard and Williams Range).

If you need a bulk trash pickup, please place your items out on the following schedule:

Thursdays: Overlea and The Points

Fridays: Apple Ridge, Dorsey's Regard, McKendree I & II, Shadow Oak and Williams Range.

Update on trash collection

We know there has been some confusion about Potomac Disposal's holiday schedule for picking up your regular trash. Under the current contract, trash continues to be picked up Mondays and Thursdays; however, if a federal holiday falls on Monday or Thursday, the regular collection will be the next day. This delayed schedule for holidays is a change from the past. Bulk trash collection occurs on Thursdays, following arrangement by the homeowner.

Recycling collection is performed by Montgomery County on the county's schedule. Our Wednesday regular pickup is delayed a day for major holidays that fall early in the week.

APRIL BOARD MEETING

Our most recent meeting of the North Village Homes Corporation Board of Directors was held Thursday, April 18.

No residents spoke. President Claudette Lease called the meeting to order and the board approved the minutes of the February 21 regular meeting.

In the financial report, Treasurer Tom Wills reported that greenspace repair was over budget, largely attributable to storm clean up expenses. Site maintenance expenses also were over budget due to substantial drain cleaning required from increasing tree-related and other debris clogging them. Accounts receivable have been creeping up over the past year. He also noted that there was \$49,000 due to our operating funds from our reserve fund accounts following payment of invoices for reserve expenditures. He moved to cancel the IOU since our operating cash is healthy

without the repayment. The board approved cancelling the IOU and thereby increased our reserve fund balances.

In the maintenance report, Lease noted that BrightView was underway as our new landscape contractor and is busy cleaning up after the winter and regularly emptying the pet stations. In her recreation report, she noted the tot lot is in heavy use, but water retention by the slide needs attention. She noted Montgomery Village Foundation recently finished replacing the new playground in Hurley Park.

In her management report, Community Manager April Steward reported a problem with trash dumping in Picton. A flyer with the trash and recycling rules in English and Spanish has been distributed. She mentioned that we had applied for conservation landscaping through the county's Rainscapes Program, which could add to our perennial garden areas on a cost reimbursed basis.

She noted a number of candidates for repair and replacement with reserve funds, including entry sign cleaning (already performed), curb painting, a retaining wall in Highland Hall area, and some concrete and asphalt replacement in a number of areas. The board discussed the slow progress of our path lighting project. Management is working with several vendors, but apparently very few fixtures exist that are appropriate to our needs.

Under new business, the board approved the 2018 audit report submitted by DeLeon & Stang and performed its annual review and approval of the community's policies. At the recommendation of our community manager, two new polices were

added: Dispute Resolution and Private Property Maintenance (PPM). These had existed previously but were not part of the official policy list in recent years. They are important to property violation enforcement.

The board approved a proposal from Busy Services for drain repair in the lower Chadburn area at a cost of \$3,875 to be funded from reserves. Also approved were a proposal from BrightView for landscaping around the new Picton entry sign at a cost of \$1,975, and a proposal for tree work by Elliott Tree Service in the amount of \$18,690.

YOUR HELP IS NEEDED

The limited parking available in our townhouse communities is a major struggle for many residents. You can help by letting our community manager know if you see cars that haven't moved week after week. They will be towed.

Do what you can to reduce littering by encouraging children to dispose of trash properly. Take a few seconds to pick up empty water bottles and other refuse you see as you walk around the community. Everyone will appreciate it.

MAINTENANCE ITEMS

We hope that you have noticed that the gazebo on Arrowhead Circle has been completely refurbished by our contractor Pro General Solutions. Now that gazebo and the one at the corner of Rothbury Drive and Arrowhead Road are "twins."

We expect the upgrades will prolong the life of the structures for many years.

Finally, the board approved a project for Chamberlain to repair an area on Hickory View Place requiring sidewalk, curb and asphalt replacement.

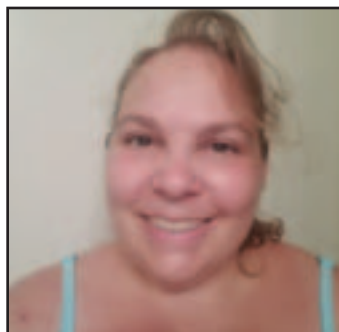
JUBILEE ROBINSON
